1. Welcome and Introductions

Chair Vernon Fields welcomed the attendees. The meeting was held in a hybrid format.

2. Approval of Meeting Summary

MOTION: A motion was made and seconded to accept the October 27, 2022, meeting summary as presented. With no objections the motion passed.

3. Status of the Current Program/KDOT Updates

Marc Hansen shared that two FFY 2023 STBG projects recently obligated:

- MARC's Operation Greenlight Operating Assistance, \$210,000
- MARC's Planning Sustainable Places program/project, \$700,000

The following 2023 STBG projects remain:

- Bonner Springs, 138th Street Improvements, Phase 1, \$2,720,000
- De Soto, 83rd Street Bridge Replacement, \$1,500,000
- KCATA, Regional Transit Corridor Improvements, Metcalf & 75th/Quivira, \$800,000
- Edwardsville, 98th Street Corridor, Kansas Ave to City Limits, \$3,797,356

The FFY 2024 STBG programmed projects were shown:

- MARC, Operation Greenlight Operating Assistance, \$210,000
- Basehor, 155th Street Improvements, \$7,435,056
- Leawood, Tomahawk Creek Parkway, \$3,760,000
- Olathe/Johnson County, Lackman Road (Blackbob), 159th 167th, \$3,100,000
- KCATA, Regional Transit Corridor Improvements, Metcalf & 75th/Quivira, \$800,000

Unified Government/KCK, Rock Island Bridge Improvements project, \$800,000 had withdrawn their project.

Allison encouraged sponsors of FFY 2024 projects to send their programmed project information to her soon, if not already.

4. 2025-2026 Call for Projects

Marc Hansen stated that the STBG programming target increased by \$3M due to the bi-partisan bill through FFY 2026. The committee continued their discussion to develop programming recommendations for STBG and CMAQ Traffic Flow.

Traffic Flow:

Total CMAQ Traffic Flow requested: \$5,344,720 2025-2026 Funds available \$1,507,010

At the previous meeting, the following recommendation was tabled until after the STBG funds were programmed:

Remove Lenexa's project from the STBG list and fund Lenexa and Leawood equally dividing the available funds
of \$1,507,010 at approximately \$753K each. Both sponsors had indicated they could still move their projects
forward.

STBG discussion:

Total STBG requested/applications \$121,573.897 2025-2026 Funds available \$31,500,000

At the previous meeting, the committee leaned towards modifying a scenario provided by the committee chairs that was based on scoring and local priority with funding selected projects at 90% with the exception of the KCATA project at 50%.

An additional scenario was presented today from the city of Shawnee which showed each local match, to fund selected projects at 100% if the local match is 40% or more, and other selected projects providing less than 40% local match to receive 90% of their request. This would encourage maximizing your ask and help spread the funds around.

Discussion:

- Not everyone can contribute more than 20% local match. Concern was expressed that small cities may not be able to apply due to an expectation of a higher local match.
- Gunnar Hand added in the chat box that local match is not only an urban/rural, small/large issue, but an equity issue for disadvantaged communities like the Unified Government.
- The committee would look at each project on a case-by-case basis.
- It would be helpful to know about the 40% match expectation ahead of time.

Following a rollcall vote regarding the preference of the two scenarios, the committee proceeded with Shawnee's scenario.

MOTION: A motion was made and seconded to accept the recommended STBG programming as noted in the Shawnee scenario with the additional \$3M to be equally split and added to the Olathe and Overland Park projects. The motion passed.

MOTION: Lorraine Basalo moved to recommend programming the available CMAQ Traffic Flow funds to the Lenexa and Leawood projects with \$753,000 each. The motion was seconded and passed.

Most of the Kansas FFY 2025-2026 funds were now programmed. Martin Rivarola shared that a small amount of Bicycle/Pedestrian funds in the amount of \$130,000 was unprogrammed. The Missouri side has Transportation Alternatives and Transit funds remaining which will be programmed by an ad hoc workgroup with representatives from each programming committee on the Missouri side. Kansas members are welcome to participate with the discussion, however; the funds are not eligible for Kansas projects. Michael Webb indicated interest.

The TTPC will receive all the recommended lists at their December meeting. If there are any issues, the committee would need to meet in December although the need is not expected. (The recommended lists are attached)

5. Other Business

Michael Webb stated that the committee came to a consensus but not a unanimous decision. Moving forward with the decision is important. Lorraine added her appreciation that there has always been willingness to work together.

6. Adjournment

With no further business, the meeting adjourned at 10:31 a.m.


