1. Welcome and Introductions

2. Vote: Approve November 2022 Meeting Summary

i. Brian Shields motions to approve, Bailey Waters seconds

3. Presentation: Osawatomie planning efforts -Mike Scanlon

- i. Osawatomie is mile zero on the Flint Hills trail; city trying to increase pull factor through trail head and tourism to attract people to city to live.
- **ii.** Found inspiration from other areas and looked at low-cost options for trail infrastructure
- iii. Found partnerships to attract trail users
 - i. Invited Midwest Endurance Race Company for an ultra marathon
- iv. Invited other communities to create a working group
- v. Tried to create a buzz around the trail
- **vi.** Created trail loops that tie the trailhead to the downtown, historic site, and levee system.
- vii. Involved members of the community to be part of the process
- **viii.** Michael Kelley asked whether changing tables and other family amenities will be added to the trail restrooms?
 - **i.** Design leaves room for another portable restroom or conversion into a full-service bathroom
- **ix.** Michael Kelley asked about resolution process to bring other cities together to create the Association of trail towns?
 - i. Agreements can be made through planning in Kansas to form an interlocal agreement and joint resolution.

4. Discussion: MARC Active Transportation program feedback

- i. MARC would like information about feedback on the program. Some program funding is not eligible for all of the same uses as in the past.
- ii. There are new activities in active transportation, and some anticipated activities.
- iii. MARC wants to ensure that Active Transportation program is serving the region well
- iv. Current activities include:
 - i. Regional Trails & Bikeways Map
 - ii. Bike/ped counter loaning
 - iii. Planning products such as the Complete Streets Network Assessment, Complete Streets Handbook, Regional Bikeway Plan, and Regional Pedestrian Policy Plan
 - iv. Committee and funding activities through BPAC, ATPC, and suballocated federal funding programming
 - v. Seasonal cycling/walking promotional campaigns
 - 1. Bike Month and fall walking campaign
 - vi. Webinars from APBP hosted monthly
- v. Anticipated Activities

- i. Regional bike and pedestrian counting program per the Regional Bikeways Plan
- ii. Regional Sidewalk Inventory per the Unified Planning Work Program and Regional Pedestrian Policy Plan
- vi. Core competencies and program purposes
 - i. MARC core competencies
 - 1. Data, connections, and funding
 - ii. Stated program purposes
 - 1. Public outreach, monitoring, and planning work
- vii. Proposed plan for 2023
 - i. Introduce new cartography for trails and bikeways data; de-emphasizing signed bikeways and emphasizing trails and protected bikeways

- 3. Collect traffic ticket data for pedestrian tickets as a predictive metric for pedestrian data
- 4. Look at fix it stand inventory
- 5. Look at opportunities to buy sidewalk sweepers as part of funding applications

- 1. Look at 15 minute city as how that may apply
- 2. Opportunity to bring communities together to discuss how to get developers to construct sidewalks
- 3. Continue and expand counter program because it helps midsize and smaller communities
- 4. Visiting with PSP sponsors to see who is implementing and publishing information
- 5. Educating communities about how private ownership effects implementation
- 6. Offering proof of concept for implementation projects

v. Karen Clawson's breakout group

- 1. Like data from bike counter program and bikeway map
- Improve suballocated funding process to invest in best projects; simplify process and ensure best projects are funded
- 3. Planning resources from MARC are helpful for smaller communities
- 4. Amplify voices to help guide MARC work and projects

vi. Questions and comments

- 1. Ask about wayfinding plan and tracking that information
- 2. Art Gough emphasized importance of signed bikeways because it can lead cyclists to protected infrastructure. Shows expertise of planning that signed routes are the safest opportunities in that area.
 - **a.** Eric responded that level of stress could be part of mapping because stress level is different from presence of infrastructure alone.
- 3. Leverage Complete streets program to connect with stress
- 4. How are google maps updated with bike signage and infrastructure?
 - a. Worth exploring how to get data onto google.
- 5. For World Cup, how will MARC get involved with bike/ped connections?

a. How to convene people together to think about bike and pedestrian connections in preparation for the event.

 - iv. Must have 20% local cash match of 20% of total budget; Not federal portion
 - v. Contact Beth Dawson for questions and to attend pre-bid workshop on January 12th
 - vi. Deadline for applications is January 27th at 4pm central
 - vii. March 2023 will be TTPC and MARC Board adoption
