Winebrenner went through the state statues definitions for police departments, law enforcement, fire department, and emergency medical services and developed a draft. This draft was reviewed, and updates suggested in the Technical & Users meeting along with adding a local government section with political subdivisions that are on the horizon so civilian staff of those agencies can access MARRS. Winebrenner, with Doug Christianson's assistance put together an updated draft. This draft was shared in the chat and on screen. It was proposed that this updated document be included on the website where anyone wanting access can review it to see if they meet the encrypted requirements.
